On December 10, 2021, Black Hills Energy Arkansas, Inc. filed an application with the Arkansas Public Service Commission for a change in the rates to be charged all classes of its customers. The request is based on a test year ending December 31, 2021 and seeks to cover increases in operating expenses and return on investment in additional facilities constructed to service customers since the Company's last general rate adjustment. The total amount of the requested rate increase is \$21,593,015. The amount of the rate change for each rate class of customer is as follows:

The Commission has not yet established a procedural schedule or hearing dates for this matter.
